Tax Season is upon us. Here are some things you will want to keep in mind-

TAX SEASON 2021

Each year, February is a trigger for folks to think about their taxes. Let's look at the deadlines and how to meet them.

So far, it looks like we are going to have a "normal" tax season without extended deadlines. Let's take a look at what's expected at the moment.

1-S-Corporations and multimember LLC's have a due date of March 15 to file their tax returns. This deadline keeps your bookkeepers and CPA's just as busy as we are around April 15, so increasing recently. Since the that is why our time is limited and we seem frazzled already in March! If you are an S-Corp or multi-member LLC, get your documentation into your bookkeepers NOW and make an appointment to get the return filed

before that time is filled with individuals trying to get an early start on the tax season.

2-Individuals, start getting your documentation together. Your deadline to file is April 18, 2022. (This delay is due to a holiday recognized in the nation's capital on April 16, a Saturday, which means the IRS will close on April 15, 2022.) If you do not receive your W-2 by February 17, contact your employer and request a copy. 3-COVID numbers seem to be onset of COVID, we have put systems in place to be able to receive your documents through a secure online portal, have a Zoom meeting to talk with you about your return, and electronically file so that we can be completely



contact-free. We also have a mail slot that you can drop paperwork through, or you can mail your tax information to us and we can take care of everything without your having to step into the office if you wish. For office visits, we do require a mask in keeping with NV guidelines, we practice social distancing and we sanitize after every client visit. Should numbers spike, we may discontinue in-person visits.

Tax Gotcha's 2021

We've experienced a couple of really difficult tax seasons since the pandemic assaulted our economy and brought a halt to a lot of people's way of life. This year looks to be a more "normal" tax season but there are still things to look out for...

Unfortunately, there will be some surprises again this tax season. Let's get you prepared so you can make the best decisions for you and your household.

1-The first thing that will affect many households this year is the Advance Child Tax Credit Payments. The IRS will send Letter 6419 in January to provide the total amount of the advance Child Tax Credit payments that were received in IMPORTANT DOCUMENT. 2021. THIS IS AN IMPORTANT DOCUMENT. **BRING IT WITH YOU** WHEN YOU ARE READY TO FILE YOUR PERSONAL TAX RETURN. (In all caps because it's very important!)

Because of these advance

payments, some households

are going to OWE taxes who

have never owed in past years

because they received this

credit in advance and did not adjust their W-4 witholdings. **2-**Just a reminder from last year: Unemployment Income is TAXABLE. It's not enough that you lost your job and you may be making less than you normally did, but you still owe taxes on that money as if it were wages.

3-Stimulus payments are NOT TAXABLE. The IRS is sending out Letter 6475. ANOTHER This will reflect all stimulus monies you received in 2021. Bring this letter to your tax preparer this year just as if it were a W-2 or 1099!

4-Business expenses paid for by the PPP Loan are deductible according to the extent they would ordinarily be deductible. This change was written into the new stimulus act in December 2020.

5-If you were allowed to work remotely, be careful of the deductions you take regarding your home office and other expenses. The TCJA 2018 eliminated unreimbursed employee expenses until 2025.

This is going to be a complicated tax year. PLUS, the IRS is already behind before this season even starts. I advise folks to go to a reliable, trusted tax advisor, even if it isn't me. A tax professional can usually save you more in taxes than the cost of their services.
