Who knew the IRS liked Halloween? They've just made some major announcements that rank right up there with

Well, it's happened! The IRS has been inundated with so many ERC claims that as of September 14, 2023, they announced an immediate moratorium on processing new Employee Retention Credits until 2024! There are a couple of things to understand. The ERC is still alive and the IRS announcement does not signal the closure of the program. If your business truly does qualify for the ERC, this news should not deter you from filing your claim in the meantime. It just means that it will be delayed as the IRS is not processing any new claims. Existing claims in the pipeline will also be delayed as the IRS takes a more stringent approach and enhanced review before doling out the money. During this hiatus, the IRS has stated its intent to bolster its internal systems to detect fraudulent claims and to provide

more comprehensive ERC guidance. While saying they will continue to work on processing ERC claims the agency received before the moratorium, the IRS has said that the standard processing time will now increase from 90 days to 180 days with many claims facing additional scrutiny.

We mentioned last month that some businesses were victims of unscrupulous ERC mills that submitted fraudulent paperwork that the business owner was unaware was incorrect. To help employers that have been the "victims of aggressive promoters", the IRS is setting up programs to assist these folks withdraw pending claims as well as avoid penalties and future compliance action. More details to be forthcoming. Many of these businesses have paid a percentage of the ERC claim to a fraudulent mill. They may still be on the hook for these fees, unfortunately.



Additionally, while a government shutdown was averted for the time being, the IRS announced it would furlough 2/3 of its staff if the government shuts down. The following activities would stop upon this shut-down: all audit functions and return examinations. issuance of non-automated refunds, nonautomated collections, and responses to taxpayer questions outside of filing season, just to name a few. They will, however, continue to process mail and payments, so do not let your estimated tax payments slide.
